

## Pirelli Pre-Paid Mastercard Promotion (“Promotion”)

### The Promoter

2. The promoter is Pirelli UK Tyres Limited, Derby Road, Burton on Trent, Staffordshire, DE13 0BH (the “**Pirelli**”).

### Promotion Period

3. The Promotion will be open during the Promotion Period. Entries received after the Claim Period will not be valid or accepted.

### Eligibility

4. To be eligible to participate in the Promotion you must be a Participant.

5. Employees or agents of Pirelli, or their families or households, or anyone professionally connected to this Promotion and any group company of Pirelli are not eligible to enter.
6. This Promotion is only available to consumers (i.e. not to any business or reseller). Each Participant may only submit the Maximum.
7. This Promotion is not redeemable with any other offer.

#### Entry

8. To claim a Refund, a Participant must purchase at least two Tyres from and have them fitted by a Dealer in a single transaction during the Promotion Period and then complete the online claim form on the Website.
9. Once the Participant has completed the claim form they must provide proof of purchase which evidences the product name, date of purchase, the fitting charge and provide their contact details along with all other required information (a "**Claim**").
10. Claims must be made and received during the Claim Period. Claims received outside the Claim Period will be marked as invalid and will not be accepted.
10. Any documents submitted in support of the Claim shall not be returned to the Participant.
11. Proof of postage will not be accepted as proof of delivery.

#### Redemption of the Refund

12. Provided the Claim has been received within the Claim Period and is validated, Pirelli will use its reasonable endeavours to ensure that delivery of the Card is made within twenty-eight (28) days of the validation of the Claim.
13. Delivery of the Card will be to the postal address provided with the Claim.
14. The Card is subject to availability and is allocated on a first come first served basis.
15. The Card will need to be activated by the Participant and full instructions on how to do this will be delivered with the Card.
16. The Card must be activated within one (1) calendar month of receipt. Failure to do so will render the Card invalid and no replacement will be issued. The Card will be deemed to be received by the Participant two days after the date of the letter enclosing the Card.
17. The Card that is issued will remain the property of the Supplier and the use of the Card will be subject to the Supplier's terms and conditions. Any queries in relation to the use of the Card or non-delivery should be referred to the Supplier.
18. Pirelli reserves the right at its absolute discretion to disqualify Claims which it considers do not comply with these Terms and Conditions.
19. Pirelli shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid Claims including, without limitation, to require further verification as to proof of purchase, as well as any other relevant details of a Participant.
20. A Claim must be made by the Participant, and must not be made through agents or third parties.

#### Privacy and Data Protection

21. Pirelli is the Data Controller for the purposes of data protection legislation. Any personal information submitted by the Participant shall be processed in accordance with Pirelli's Privacy Policy, which is available to view at [www.pirelli.co.uk/privacy](http://www.pirelli.co.uk/privacy)

#### General

22. Pirelli reserves the right to withdraw the Promotion at any time before the end of the Promotion Period.
23. Pirelli reserves the right to hold void, cancel, suspend, or amend the Promotion where it becomes necessary to do so.
24. Pirelli reserves the right, acting reasonably and in accordance with all relevant legislation and codes of practice, to vary the Terms and Conditions.
25. Pirelli will not be responsible or liable for: (a) any failure to receive submissions due to transmission failures and other conditions beyond its reasonable control; (b) any late, lost, misrouted, or damaged transmissions or Claims; (c) any computer or communications related malfunctions or failures including but not limited to the Website; (d) any disruptions, losses or damages caused by events beyond Pirelli's control; or (e) any printing or typographical errors in any materials associated with the Promotion.
26. To the maximum extent permitted by applicable laws, Pirelli, its agents or distributors will not in any circumstances be responsible or liable to compensate the Participant or accept any liability

for any injuries, losses or damages of any kind arising from participation in or in connection with the Promotion. The above limitation of liability shall not apply to liability arising from fraud (including fraudulent misrepresentation) or death or personal injury caused as a result of Pirelli's negligence. The Participants statutory rights are not affected.

27. The Participant will be solely responsible for any and all applicable taxes and any other relevant costs or expenses which are not stated in the Terms and Conditions as being included.
28. The Promotion is governed by English law and the Participants shall submit to the jurisdiction of the English Courts.
